# **BRAIN INJURY (BI) AND CHILD WELFARE**

#### MORE THAN 500,000 ADULT COLORADANS HAVE SUSTAINED A BI. BI MIGHT <u>AFFECT</u>:

- Attention
- Concentration
- Processing
- Memory
- Communication
- Planning/organizationProblem-solving
- Mental flexibility
- Impulsivity
- Emotional reactivity

### BI IS <u>MOST LIKELY TO AFFECT</u> PEOPLE ALSO DISPROPORTIONATELY REPRESENTED IN CHILD WELFARE:

- Members of racial and ethnic minoritized groups
- Veterans
- People who've experienced incarceration
- People who've experienced homelessness
- People who've experienced intimate partner violence

### DEPARTMENTS' AND COURTS' LEGAL DUTIES:

- Bl is almost always a disability under <u>civil rights</u> <u>laws</u> like the ADA. 28 C.F.R. § 35.108.
- Individualize & accommodate.
- Determine whether accommodations can prevent certain removals. C.R.S. § 24-34-805(2)(e).
- Include accommodations in treatment plans. C.R.S. § 19-3-507(1)(c).
- Ensure reasonable efforts comply with the ADA. C.R.S. § 19-3-100.5, 19-3-208.
- Consider accommodations if assessing no appropriate treatment plan. C.R.S. § 19-3-604(1) (I)(b).
- Show disability affects child before restricting parenting time or responsibilities. C.R.S. § 24-34-805(2)(a)(III).

### STEPS TO BEGIN ADDRESING BI:

- Screen for BI in all adults and children.
- <u>Provide starter accommodations</u>, including in <u>court</u>.
- Refer to BI supports and services.
- Consider <u>co-occurring conditions</u>.

The goals of child welfare and disability non-discrimination are mutually attainable and complementary. -<u>Federal civil</u> <u>rights agencies, 2015</u>.

It is likely that fewer children would experience the trauma of removal if appropriate interventions are implemented for parents with Bl. -<u>TBI State</u> <u>Partnership Program, 2023</u>.
