Marlboro's curriculum is anchored by a Clear Writing Requirement that is portfolio rather than course based, a highly participatory community model where students, faculty, and staff contribute meaningfully to the College's governance, and significant opportunities for place-based, experiential, and community engaged learning.

Primary duties include: Promote academic excellence in all areas of undergraduate and graduate education, guide faculty and staff to address the changing needs of students within the College's academic program and student life, establish retention and enrollment goals and comprehensive retention plan, develop regional and international partnerships to expand opportunities for students and faculty, and work actively with board members and donors to support new and ongoing academic and student life initiatives.
