In antiquity, Socrates held that the laws were his "true parent." For then as now, laws help to constitute and regulate the family, school, church, commercial, and governmental institutions. They therefore affect the lives of everyone throughout, although conversely human beings make the law. Legal foundations, developments, and effects are consequently of intrinsic interest and concern to many disciplines and their students. The Legal Studies curriculum is accordingly designed not so much for the pre-law student, as for any student whose liberal education seeks to understand the formative bases of human civilization and culture.

Overview:

Open to UMaine students majoring in any subject

Students must complete a minimum of 18 credit hours in courses primarily focused on legal matters.

Minimum grade for courses to count toward minor: C-

Residency Requirement: a minimum of 9 credit hours must be completed at the University of Maine
