DECLARATION OF FINANCES FOR INTERNATIONAL GRADUATE STUDENTS

All international students are required by U.S. immigration regulations to show proof of financial ability to attend an educational institution in the United States before immigration documents can be issued. The University of Maine requires that you present evidence of financial support for at least one academic year. The estimated expenses can be found here: <https://umaine.edu/international/international-admissions/expenses/>.

Financial documents must be in English and clearly indicate the name of the financial institution, the name of the account holder, the currency, balance available, and must be dated less than 12 months ago. Funds must be liquid or currently available. Financial documents can be scanned copies but the Office of International Programs (OIP) reserves the right to request original documents at any time.

If you will be self-supported (choose one):

- A. Submit this form with the "Certification from the Bank" section completed, signed, and certified by a Bank Official and
- B. Submit a bank statement or certificate of balance signed by a bank official on official letterhead indicating the account opening date, average balance, and current balance.

If you will be supported by a sponsor (choose one):

- A. Submit this form with the "Affidavit of Support" section completed by your sponsor a bank statement or certificate of balance signed by a bank official on official letter head that clearly states the balance available in your sponsor's personal bank account
- B. Submit this form with the "Affidavit of Support" section completed by your sponsor and the "Certification from the Bank" section on completed, signed, and certified by a Bank Official
- C. Submit an original letter from the sponsor's bank on bank letterhead indicating available funds and that the sponsor is willing to support the student. This letter would replace the need for both the "Affidavit of Support" and "Certification from the Bank" sections to be completed.
