



**VISITING GRADUATE STUDENT ADMISSION FORM  
CERTIFICATE OF STATUS**

A student who wishes to enroll for a semester or academic year in the Graduate School at The University of Maine, and who intends thereafter to return to the graduate school, in which he/she is enrolled for an advanced degree, may be admitted as a Visiting Graduate Student.

He/She must be officially admitted to another graduate school, be in good standing, and actively pursuing a graduate degree program. He/She need not submit a full transcript of credits, but must ask the dean of his/her graduate school to complete the form below and return it to The University of Maine. Note: International applicants must document appropriate finances and provide a TOEFL of 550.

Admission to The University of Maine as a Visiting Graduate Student does not guarantee admission to any particular course of study. A Visiting Graduate Student will be permitted to register only for those courses for which he/she is judged to be eligible by a faculty advisor or the instructor of the course, on a space available basis.

For any student admitted on this basis, it is understood that his/her registration shall terminate at the end of the semester or the academic year for which the student is enrolled. If, at a later time, the student wishes to apply for admission to the Graduate School of this University to work toward a degree, the student must make formal application and submit complete credentials. If a Visiting Graduate Student is officially admitted to a degree program at The University of Maine, he/she may petition to have the credits for courses taken as a Visiting Graduate Student transferred into the degree program.
