

## University Park Family Housing Application Instructions

Thank you for your interest in housing at University Park. University Park provides housing for students, faculty, and staff with families. This includes couples, couples with dependent children, and single parents with dependent children.

To meet University Park eligibility requirements, students need to be registered for at least six hours of courses as an undergraduate, or three hours as a graduate student. Faculty and staff must show proof of their full-time status with the University.

University Park offers one and two bedroom units. A one-bedroom apartment will accommodate a family of two. A two-bedroom apartment will accommodate a family of four.

Monthly rates effective July 1, 2020, for a twelve (12) month lease. All rates are subject to change.

- One bedroom apartment: \$780.00
- Two bedroom apartment: \$898.00

Monthly rent includes the following utilities and services:

- Heat
- Hot and cold water
- Cable television
- Internet service

Please note, electricity charges are paid by the resident and pets are not permitted in University Park.

All leases are for one year or through June 30 if entering after July 1. A minimum lease period or a higher rental rate may be required for occupancy of less than nine months.

### APPLICATION PROCESS

All applicants are placed on a waiting list for an apartment at University Park, and are assigned as apartments become available.
