Note.

- These two tables comprise all active employees coded by HR as class = 6, 7, or 9 (i.e., "faculty").
- T/TE = tenured or tenure-eligible. (A retired tenured professor who returns as part-time faculty is reported "not on tenure track.")
- Faculty having joint appointments are included in each unit, with FTE apportioned consistent with the appointment.
- Faculty on full-year sabbatical are counted as .5 FTE, as are faculty on one-semester unpaid leave; faculty on full-year unpaid leave are not included.
- College configuration reflects the present-day configuration.
- Beginning in 2011-2012, HR provides OIR with updated PATFA faculty data in the spring (in addition to the fall PATFA data). Any comparisons of PATFA FTE faculty involving earlier years should be considered with this in mind.

* For these earlier years, it would be exceedingly difficult to honor Note 5 and assign all EHD faculty to one of the present-day EHD academic units.
