#### **Course Description**

This course introduces students to the role of economics in health and health care, as well as health and social policy. We will survey major topics including: the economic and social determinants of health; the markets for health care and insurance; and the role of government in health and social policy. In doing so, we will focus on the United States with comparisons to other countries. As a special topic, we will consider the economics of risky health behaviors.

This course satisfies the General Education requirement in Social Contexts and Institutions. It is worth three credit hours.

Prerequisite: C- or better in ECO 220 or permission

#### **Learning Outcomes**

- Use economic models to analyze health-related decisions by individuals, physicians, insurance providers and governments, while accounting for the interactions between these entities.
- Evaluate theoretical models relative to real-world and empirical applications.
- Critically review the health economics literature (i.e., intuit the empirical techniques, describe strengths and weaknesses, explain how the results contribute to the literature and policy).
- Use economic data to visualize and analyze issues in health economics.
- Communicate about issues in health economics, both orally and in writing.
- Describe health and social policy in the United States, as well as advantages and limitations compared to other countries.

#### **Course Structure**

This course will be delivered asynchronously online. Every Tuesday, I will post new materials on Brightspace. You are expected to complete them by the following Monday at 11:59pm Eastern. In some weeks, you will work through course modules, all of which include graded components such as discussion boards and/or questions that must be answered in a Brightspace form. In other weeks, you will complete assignments or the take-home exam. Please refer to the course outline for a list of modules and deadlines.

Solomon and I will be available to meet via Zoom. Please email us to arrange an appointment. You are also encouraged to email Solomon or I with questions about the course. We expect you to be professional and concise; long, technical questions should be addressed by appointment. We will respond to email in three days or less. Please send all correspondence using your 'maine.edu' email account. We will not respond to email from other accounts or Brightspace messages.

To complete this course, you will need access to Brightspace, Kaltura, Zoom and your 'maine.edu' email account. You are expected to be familiar with these platforms. #### **Grading**

#### **Discussion Boards**

Some modules include discussion boards, which are worth 10 percent of your overall grade. You must contribute to each discussion board on an individual basis during the week in which the associated module is to be completed (i.e., the module will be posted on Tuesday and must be completed by the following Monday at 11:59pm Eastern).

Each discussion board will be equally weighted and graded out of five as follows:

- 0.0 Did not contribute to the discussion board on time
- 2.5 Contributed to the discussion board on time with some effort
- 5.0 Contributed to the discussion board on time with good effort

I will accept late submissions for up to 48 hours without penalty, after which they will no longer be accepted. This policy is in place because I realize that unforeseeable things may prevent you from completing course requirements on time.

#### Questions in Modules

Some modules include questions that must be answered in a Brightspace form. They are worth 10 percent of your overall grade. The questions must be answered on an individual basis and submitted during the week in which the associated module is to be completed (i.e., the module will be posted on Tuesday and must be completed by the following Monday at 11:59pm Eastern).

Each set of questions will be equally weighted and graded out of five as follows:

- 0.0 Did not complete the questions on time
- 2.5 Completed the questions on time with some effort
- 5.0 Completed the questions on time with good effort

I will accept late submissions for up to 48 hours without penalty, after which they will no longer be accepted. This policy is in place because I realize that unforeseeable things may prevent you from completing course requirements on time.

#### Assignments

There will be five assignments, which must be completed on an individual basis. Each assignment is worth 10 percent of your overall grade, for a total of 50 percent. As shown in the course outline, assignments will be posted on Tuesday and must be submitted to Brightspace by the following Monday at 11:59pm Eastern.
