Course Description: Analysis of the fundamental characteristics of an open macroeconomy including exchange rate determination, balance of payments adjustment, income determination, financial flows, effect of monetary and fiscal policies, economic integration and global monetary issues.

Objectives and Learning Outcomes: Upon completion of this course, students will have an advanced quantitative and qualitative understanding of: the microeconomic underpinnings of the benefits from international trade; the operation of the exchange rate market; and the interaction of goods markets, financial markets, and labor markets in determining national income, prices, and employment in an international setting. Students' understanding of these concepts and issues will have been displayed through their learned analytical skills (modeling and graphics) and narrative explanations as demonstrated by the course requirements.
